SUBJECT: New Fees Effective July 1, 2017

Per Senate Bill 1006, the following fees will increase effective July 1, 2017:

- Vehicle Sales Tax 6% (previously 5%)
- Title fee \$ 15.00 (\$ 10.00 title fee + \$5.00 A James Manchin fee)
- Duplicate Title fee \$ 15.00 (\$ 10.00 title fee + \$5.00 A James Manchin fee)
- Salvage Title fee \$ 22.50
- Cosmetic Total Loss fee \$ 22.50
- Reconstructed Title fee \$ 15.00 (\$ 10.00 title fee + \$5.00 A James Manchin fee)
- Legal Heir Title Transfer fee \$ 15.00 (\$ 10.00 title fee + \$5.00 A James Manchin fee)
- Lien Recording fee \$ 10.00
- Transfer of Registration \$ 10.50
(including Legal Heir)
- Duplicate Decal, Plate & Registration \$ 10.00
- Class A Registration \$ 51.50
(\$ 50.00 registration fee + \$1.50 litter & insurance fees)
- Additional annual registration fees for any class Alternative Fuel Vehicles:
 - Hydrogen or Natural Gas \$ 200.00 (+ Class A registration fee of \$ 51.50)
 - Exclusively Electric \$ 200.00 (+ Class A registration fee of \$ 51.50)
 - Electric & Petrochemical Fuels \$ 100.00 (+ Class A registration fee of \$ 51.50)

The *Friends of Coal* plates will now be sold at all Regional Offices with the fees as follows:

- New plate \$ 76.50
- Renewal \$ 66.50

The plate class has been requested as "AFC". Once programmed into the mainframe, you will be notified.

The *In God We Trust* plates will now be sold at all Regional Offices with the fees as follows:

- New plate \$ 61.50
- Renewal \$ 51.50

The plate class has been requested as "AIG". Once programmed into the mainframe, you will be notified.

The Class A Registration fee does NOT apply to the registrations that are a 10-year registration (i.e. POW, Purple Heart, etc.)

Please note, these fees will be assessed by the DATE OF SALE. Vehicles sold July 1, 2017 or after will be subject to the new fees.
